


#### You Must Have Been A Beautiful Baby

#### **Going Above and Beyond**

My name is Liz Gillenwater, and I am the Executive Director for the Columbus Program. It has been over a year since the start of the COVID-19 pandemic. When the announcement came in March of 2020, many of our team members had no idea what to expect. The world was shutting down and everyone was ordered to stock up on essential items, only go out for emergencies and to stay at home. We were all in a state of shock, denial, bewilderment and to be honest, frightened. Many of our friends and family were mandated to work from home and thousands lost their jobs. Celebrations were cancelled, family gatherings were non-existent and our children were sent home to be homeschooled. It seemed as if everything was turned upside down, and we were forced to "figure it out." One day turned into a week, then a week turned into a month, and before we knew it, we had made it a year. I have been continuously humbled and inspired by the group of outstanding professionals on the Columbus team. They have been brave, dedicated hospice warriors, strapping on their PPE every day and heading out into the community to care for our dying patients. I am proud of our team and the way they have pulled together during this very difficult year. Everyone stepped up and kept our program strong. In particular, I would like to take this opportunity to mention a department that has changed the most during the pandemic, the Volunteer Department. At the beginning of the pandemic, we had over 30 volunteers and many more interested in signing up with Bella Care. The volunteer program was alive and thriving with volunteers, visiting our patients out in the community. Shortly after the national shut down, hospices were issued an 1135 waiver that would relax our volunteer hours requirement. Our Volunteer Coordinators Scott Gorbold and Kendra Lambert, found themselves almost completely closing down the department. After several meetings to develop a plan for the coming months, we started to cross train them on many office administrative responsibilities like scanning, filing and answering the phones. After they mastered those tasks, they started training on putting in staff schedules, entering verbal orders and many more things. They took on some large projects for myself and other managers. As things evolved, they learned about our new payroll system, audited HR files and started to do new employee orientations. Scott and Kendra have gracefully remained dedicated to our organization and since, have become vitally important the success of the administrative operations of the Columbus program. While I know Scott and Kendra are eager to reopen the volunteer department and start recruitment and management of their volunteers, it is important that they know the impact they have had in the general operations. They are a joy to have in the office every day, and we cannot thank them enough for everything they have done in the past year.
